## Request for Proposal RFP 25-06 Exterior & Window Washing

Kodiak Island Housing Authority (KIHA) is soliciting proposals from qualified vendors to provide professional exterior washing and window cleaning services for multiple residential apartment complexes located in Kodiak, Alaska. The scope of work includes washing building exteriors, windows, and associated structures.

The intent is to select a contractor who demonstrates experience, safety, reliability, and competitive pricing. This contract may be awarded for a one-time service or renewed for seasonal cleaning based on performance.

#### 1. SCOPE OF WORK

- a. The selected contractor shall:
  - i. Perform soft wash or pressure wash of siding, fascia, and trim (as appropriate for each surface).
  - ii. Clean all exterior windows and screens on all floors (1–3 stories).
  - iii. Use methods that are safe for tenants, property, and landscaping.
  - iv. Coordinate access with KIHA for buildings that may require tenant notification.
    - 1. KIHA will be available to assist with screen removal the day prior to scheduled window washing, if needed
  - v. Provide their own equipment, water access solutions (if needed), and safety gear.
  - vi. Remove all debris and cleaning residue upon completion.

  - vi. Proof of insurance showing general liability and workers' comp
  - vii. Alaska Business License
  - viii. Native Preference if applicable
    - ix. Signed Non-collusive Affidavit

#### 7. PREFERENCE STATEMENT

a. American Indian/Alaska Native owned firms and individuals are encouraged to participate. Preference in the award of this contract will be given to Indian-owned economic enterprises and individuals. The project is subject to Section 7(b) of the Indian Self-Determination and Education Assistance Act (25 U.S.C. 450 e(b)). To qualify as an Indian-owned enterprise, the proposal must include documented evidence that the enterprise is at least 51% Indian-owned and evidence of operation and control showing a substantial Indian involvement in the day-to-day management and business activities of the enterprise. Proposer must certify whether they are an Indian organization or Indian owned economic enterprise, or how opportunities for employment will be given to Indians for this project.

### 8. ADDITIONAL COMMENTS

- a. KIHA reserves the right to accept or reject any or all proposals and to waive any informalities or irregularities in the proposal process.
- b. No proposal shall be withdrawn for a period of (90) days after the deadline date for receipt of the proposal without the written consent of KIHA.
- c. This RFP does not constitute a contract or obligate KIHA to proceed with any services until a formal agreement is executed.
- d. This project is classified as routine maintenance and is not subject to Davis-Bacon wage requirements.
