### REQUEST FOR PROPOSAL RFP 25-07 CW Meter Base Replacement

KIHA is soliciting proposals from qualified and licensed electrical contractors to provide all labor, materials, and equipment necessary to replace the existing deteriorating meter base infrastructure at CW 1321 Selief Way, a 12-unit apartment complex. The project includes replacement of 12 individual meters, a house power meter, and a spare meter box.

#### 1. SCOPE OF WORK

- a. Demolition and removal of existing meter base components.
- b. Supply and installation of new meter base equipment to match existing electrical service configurations.
- c. Replacement of aluminum conductors if determined necessary.
- d. Coordination with local utility provider for service transfer and inspections.
- e. Protection of adjacent occupied units during work (CW 40 is currently vacant).
- f. Work must comply with local, state, federal, and NEC codes.

#### 2. SITE CONDITIONS

- a. CW 1321 Selief is an occupied multi-family residential building.
- b. Access to each meter must be maintained throughout the project.
- c. Contractors are expected to coordinate work to minimize service disruption.
- 3. DAVIS BACON COMPLIANCE
  - a. This project is classified as residential construction. The applicable U.S Department of Labor Wage Determination for Kodiak, Alaska will be included in the contract documents. All workers performing work under this contract regardless of classification, including laborers, mechanics, electricians, and any other applicable trades, must be paid no less than the prevailing wages and fringe benefits listed in the applicable wage determination

- ix. Safety Plan If work involves physical job sites or labor
- x. Equipment List If relevant to project delivery
