REQUEST FOR PROPOSAL RFP 25-09 FIC Electrical Upgrade

Kodiak Island Housing Authority (KIHA) is soliciting proposals from qualified and licensed electrical contractors to upgrade the main electrical service at the FIC 700 building located at 2815 Woody Way. The existing 200A service must be upgraded to 400A, which will require trenching, new conduit installation, coordination with Kodiak Electric Association (KEA), and repaving. This upgrade prepares the facility for future installation of a commercial laundry and kitchen. The selected contractor will provide design coordination, all labor, materials, permitting and site restoration.

1) SCOPE OF WORK

The selected contractor shall:

- a) Assess and design a compliant 400A service upgrade to replace the existing 200A system
- b) Coordinate with KEA for transformer upgrade and electrical connections
- c) Coordinate with KEA during trenching, conduit installation, and site restoration (paving, surfacing, etc.) across the parking lot to the KEA transformer
- d) Install all new panels, conductors, and equipment necessary to fully energize the 400A service
- e) Provide spare capacity for future commercial laundry and kitchen loads
- f) Comply with all codes, permits, inspections, and utility requirements
- g) Maintain clean, secure work areas and minimize disruption to tenant or building operations
- h) Restore any impacted areas to original or improved condition

2) PROPOSAL REQUIREMENTS

All proposals must include the following to be considered responsive:

- a) Detailed Work Plan Description of work approach, sequencing, timeline, and anticipated subcontractors
- b) Project Schedule Mobilization date, work duration, and milestone timeline
- c) Price Proposal Lump sum cost, with any allowances or optional unit pricing for contingencies clearly stated
- d) Safety Plan If work involves physical job sites or labor
- e) Equipment List If relevant to project delivery
- f) Company Background Licensing, certificates, and similar past projects
- g) Proof of Insurance General Liability and Workers' Compensation
- h) Valid Alaska Business License Matching submitting entity
- i) Signed Non-Collusive Affidavit Template available upon request
- j) Native Preference Documentation If applicable, per Section 7(b)

3) EVALUATION CRITERIA

Proposals will be evaluated based on the following weighted criteria:

- a) Price 30 pts
- b) Work Plan and Schedule 25 pts
- c) Relevant Experience 20 pts
- d) Safety and Risk Mitigation 10 pts
- e) Native Preference 15 pts Total possible points: 100pts

- b) No proposal may be withdrawn within 90 days after the submission deadline without written consent.
- c) This solicitation does not constitute a contract, and no work shall begin until a written agreement is executed.

The selected contractor must comply with all applicable federal labor standards, including payment of prevailing wages to all mechanics and laborers. The applicable wage determination for Kodiak Island Borough will be included as an attachment to the final contract. Certified payrolls will be required.
