REQUEST FOR PROPOSAL RFP 25-10 HARBOR VIEW ELECTRICAL UPGRADE

Kodiak Island Housing Authority (KIHA) is soliciting proposals from qualified and licensed electrical contractors to complete an electrical upgrade at the Harbor View property located at 201 Kashevaroff Drive. The project involves installing electrical infrastructure to support a commercial washer/dryer set in the facility laundry room. The selected contractor will provide design coordination, all labor, materials, permitting, and any necessary trenching or site restoration.

1) SCOPE OF WORK

The selected contractor shall:

- a) Evaluate existing electrical capacity and layout at Harbor View
- b) Tie into the existing SquareD panelboard (Type NQOB) in the laundry room or propose alternative routing
- If panel capacity is insufficient, propose and execute a code-compliant upgrade or subpanel installation
- d) Install necessary conduit, wiring, breakers, and outlets to support a commercial washer and dryer set
- e) Provide appropriate circuit labeling and documentation
- f) If exterior routing or new service is required, perform trenching, backfill, and site restoration in accordance with code and KIHA standards
- g) Coordinate with Kodiak Electric Association (KEA) if utility involvement or service modification is needed
- h) Ensure compliance with all applicable electrical codes, permits, inspections, and safety standards
- i) Maintain a clean, secure work area and minimize tenant disruption

2) PROPOSAL REQUIREMENTS

All proposals must include the following to be considered responsive:

- a) Detailed Work Plan Description of approach, sequencing, potential options for routing or upgrades
- b) Projected Schedule Estimated timeline including mobilization, permitting and completion
- c) Price Proposal Lump sum or itemized cost with allowance for unknowns
- d) Safety Plan
- e) Equipment List
- f) Company Background Including licensing, certifications, and brief history
- g) Proof of Insurance General Liability and Workers' Compensation

- h) Alaska Business License
- i) Electrical Contractor License
- j) Non-Collusive Affidavit
- k) Native Preference Documentation If claiming 7(b) preference

3) EVALUATION CRITERIA

Proposals will be evaluated based on the following weighted criteria:

- a) Price 30 pts
- b) Work Plan & Schedule 25 pts
- c) Relevant Experience 20 pts
- d) Safety and Risk Mitigation 10 pts
- e) Native Preference 15 pts Total possible points: 100pts

- c. This solicitation does not constitute a contract, and no work shall begin until a written agreement is executed.

If applicable, the selected contractor will be solely responsible for ensuring full compliance with all federal labor standards, including the payment of prevailing wages to all workers performing on-site project duties. The relevant wage determination for Kodiak Island Borough will be included in the final contract, and certified payroll submissions will be required.
