Electrical Upgrades and Panel Replacements

Kodiak Island Housing Authority (KIHA) is requesting quotes from qualified electrical contractors to perform routine electrical upgrades and panel replacements across four project sites: Larsen Bay Rental #5, Cliffwood 1319 Selief, Old Harbor, and Akhiok. The selected contractor will provide all labor, materials (excluding the electric range for Larsen Bay, which will be provided by KIHA), equipment, travel coordination, and supervision necessary to complete the work in compliance with all applicable codes and KIHA policies.

1) SCOPE OF WORK

- a) Larsen Bay Lot 1 Block 19 Rental #5
 - i) Convert the existing propane range to an electric one
 - ii) KIHA will supply the new electric range
 - iii) Install appropriate 220V outlet approximately 30 feet from panel
 - iv) Verify panel capacity and breaker sizing: install new breaker if needed
 - v) Ensure code-compliant outlet location, wiring, and connection

b) Cliffwood 1319 Selief

- i) Replace house power panel which currently powers laundry, lighting and boilers
- ii) Existing breakers are reportedly damaged and/or malfunctioning
- iii) Remove and dispose of existing panel
- iv) Install new panel with properly labeled circuits, secure terminations, and grounding
- v) Include surge protection if recommended for shared utility system

c) Old Harbor

- i) Addresses
 - (1) Lot 12 Block 1A
 - (2) Lot 3A Block 5
 - (3) Lot 10 Block 1A
- ii) Replace the main electrical panel for each unit
- iii) Ensure proper labeling of all circuits
- iv) Verify grounding and bonding meet code
- v) Correct any improper or hazardous wiring practices
- vi) Coordinate with KIHA to minimize resident disruption during outage

d) Akhiok Homestart Lot 6A Block 2

- i) Replace the main electrical panel and correct the following noted deficiencies
 - (1) Panel #62: install missing 'dead front' protective cover
 - (2) Subpanel #64: correct improperly terminated wiring
 - (3) Subpanel #65: Secure loose cable entry using an approved connector
- ii) Ensure final configuration passes inspection and is fully code compliant

 - i) Section 7(b) form provided
- g) Project Availability
 - i) Brief timeline or confirmation of availability to begin work upon award
- h) Relevant Experience
 - i) 1-2 recent projects of a similar scope.

3) EVALUATION CRITERIA

Proposals will be evaluated based on the following weighted criteria:

- a) Total price 70 pts
- b) Project availability and timeline 10pts
- c) Relevant Experience 5pts
- d) Native Preference 15pts Total Possible Points – 100

7) NATIVE PREFERENCE STATEMENT

a) American Indian/Alaska Native-owned firms and individuals are encouraged to participate. Preference in the award of this contract will be given to Indian-owned economic enterprises and individuals in accordance with Section 7(b) of the Indian Self-Determination and Education Assistance Act (25 U.S.C. 450e(b)). To qualify, proposals must include evidence of 51% Indian ownership and documentation of daily management and control by Indian persons.

8) ADDITIONAL COMMENTS

- a) KIHA reserves the right to accept or reject any or all proposals and to waive informalities.
- b) No proposal may be withdrawn within 90 days after the submission deadline without written consent.
- c) This solicitation does not constitute a contract, and no work shall begin until a written agreement is executed.
- d) This project is federally funded and is subject to the provisions of the Davis-Bacon Act (40 U.S.C. §§ 3141–3148). The selected contractor must comply with all applicable federal labor standards, including payment of prevailing wages to all mechanics and laborers. The applicable wage determination for Kodiak Island Borough will be included as an attachment to the final contract. Certified payrolls will be required.
